1 Introduction

1.1 This Information Notice provides highlights of EASA developments and CAA activities covering the period 1 November to 19 December 2013.

2 EASA Management Board

- 2.1 The Management Board met on 9-10 December. An annual "special" meeting took place on the afternoon of 9 December, the main agenda item was a presentation of the Article 62 evaluation final report.
- 2.2 The formal Board meeting on 10 December included a number of substantive items:
 - i) Rulemaking Strategy:

The Management Board welcomed a joint Agency/Commission paper on a strategy for 'better regulation'. This encompassed measures not only for a simpler EASA rulemaking programme, but also other initiatives that will contribute to a more risk based and proportionate approach to regulation, including better implementation and standardisation. Emphasis was placed on the need to provide more support for all stakeholders, including helping better understanding of the regulations. A revised draft 2014-2017 Rulemaking Programme was presented in which less rulemaking tasks would be undertaken in 2014 and 2015. The draft is available at Draft Rulemaking Plan 2014-2017 Revision 1.

ii) General Aviation roadmap progress:

The Agency reported on progress in implementing the GA roadmap, including the work of the SSCC GA sub-group. That sub-group has presented a first edition of projects and proposals that it considers necessary for future development of the GA strategy. The Agency also reported on meetings it had had, with GA representatives which will be supplemented by a number of subject-specific workshops. The Management Board endorsed a proposal to establish a small GA group of NAA representatives to help take the roadmap forward, stressing that this must help to speed up the process rather than slow it down. UK offered to join the group.

iii) European Aviation Safety Plan (EASp).

The MB welcomed the 4th iteration of this plan endorsing various important safety actions. The UK noted that legal backing was needed to enable more effective measures on ground handling; the Commission assured the MB that this would be considered as part of a review of possible future amendments for the EASA Basic Regulation.

- 2.3 The agenda also included a regular report from the Executive Director, a report from the Certification Strategy Industry EASA (CSIE) working group, and some financial/administrative items, including a report from the FABs Advisory Board, adoption of the Business Plan 2014-2018, Adoption of the Budget 2014, and discussion on Planning Documents for 2015.

3 EASA Committee

- 3.1 Following the EASA Committee meeting held 16-17 October, the re-cast of Regulation 2042/2003, including OSD items, was circulated to the Committee for vote by written procedure. The UK voted positively.
- 3.2 The EASA Committee meeting scheduled to take place on 11-12 December was cancelled.

4 Other Rulemaking Topics

4.1 Aerodromes

Development of the UK processes and systems to transition to the EASA rules continues as planned. The Bristol and Aberdeen trials have been completed, whilst the Norwich trial, which is intended to be a "dress rehearsal" for transition, started on 12 November and will be complete by mid January.

4.2 Airworthiness

<u>Commission Regulation (EU) 1088/2013</u> amending Regulation (EC) 1005/2009, which provides a derogation regarding the import/export of essential aircraft equipment containing halons, was published in the OJEU on 5 November 2013.

4.3 OPS – Commercial Air Transport Operations (Part CAT)

On 21-22 November, the rulemaking group for RMT.0232 and .0233, 'Commercial air transportation aeroplane operations at night or in IMC using single-engine turboprop aeroplanes', held their final planned meeting ahead of publishing proposals in the new year. It is expected that an NPA and associated RIA will be issued by EASA at the end of February or early March 2014.

4.5 Standardised European Rules of the Air (SERA)

The Agency published <u>CRD 2012/10</u>, Transposition of Amendment 43 to Annex 2 to the Chicago Convention on remotely piloted aircraft systems (RPASs) into common rules of the air, on 18 November with a closing date for comments of 18 December.
