The Civil Aviation Authority allows the privileges specified in Section 2 to be exercised by the named applicant for up to 8 weeks from the date entered on this Authorisation. Subject to the applicant's examiner's Authorisation (by signature below) of the successful completion by the applicant of the applicable requirements of CAP2118.

Instructions to CAA Inspector or FRTOL Senior Examiner

The FRTOL Senior Examiner is responsible for ensuring that the applicant has fulfilled all the applicable training and assessment requirements and that the Examiner Assessment of Competence (EAoC) has been passed in accordance with the requirements of CAP2118.

Only the FRTOL Senior Examiner conducting the EAoC may sign this Temporary Authorisation.

Any Temporary Authorisation issued when the applicable requirements have not been fully met will be immediately provisionally suspended and the subsequent application may be rejected.

The FRTOL Examiner must carry this signed original Temporary Authorisation whenever exercising the privileges of this Temporary Authorisation.
