Applicability:

Where an FDD appoints an individual Flying Control Committee (FCC) member to provide technical support via a fixed or mobile aeronautical radio station at a specified flying display event permitted by the CAA in accordance with Article 86 of the Air Navigation Order 2016, as amended, that FCC member must be able to demonstrate to the FDD that whilst in use they:

- Understand the safety implications of the transmission of safety and standard warning calls at appropriate times during the display event, and
- Understand the need for clarity between the roles and functions of the ATCO/FISO/AGCS, FDD and other FCC members.
