## GUIDANCE NOTES

### GUIDANCE NOTE 1: Important Information

A copy of this declaration is to be retained by the pilot and the ATO/DTO/Flying Club

Please note that for pilots applying for this declaration, the following requirements will need to be met;

- Hold a valid licence (that is a licence that is not subject to suspension, limitation or other enforcement action by the issuing authority)
- Hold at least a valid ICAO Class 2 Medical issued by the issuing authority
- Hold an “English proficient” endorsement on their ICAO licence, to meet the minimum level 4 proficiency, or have their proficiency confirmed by a UK CAA Approved Language Proficiency Assessment Centre if no such endorsement applies or the candidate wishes to be credited with proficiency levels 5 or 6 (Form **SRG1199** applies).
- A new acclimatisation flight, as detailed in section 4, must be undertaken for each annual application.

### GUIDANCE NOTE 3: Supporting documentation required with the application

- The original or copies of your current Third Country ICAO licence and medical.
- The original or copies of flying logbook(s)
- Proof of your ID (This can be a certified copy of your valid passport (preferred)/full UK photographic driving licence, or a close-up photo of you holding your ID in which your face and ID are clearly visible)
- Completed application form SRG2142 for the verification of your Third Country ICAO licence. (Confirmation of the application reference number annotated on this form is sufficient).

Please note that you may be required to meet additional requirements as set out by the National Aviation Authority (NAA) that issued your ICAO licence, in order for them to release your personal information to the UK CAA.

The UK CAA will only accept the verification directly from the NAA that issued the ICAO licence, and it will remain valid for six months from the date of receipt.

### GUIDANCE NOTE 4: What happens next?

**Please allow a minimum of 10 working days for processing.** Incomplete applications are not subject to the 10-working day turnaround time until all requirements are met. Verification from the ICAO issuing Authority is required before a declaration can be issued.

The UK CAA will apply to the National Aviation Authority that issued your Third Country ICAO licence for verification of your licensing privileges. Your application will then be on hold until we receive this verification, which will be subject to your specific NAA's own turnaround times.

Once we have received the verification and assessed that you meet the requirements based on the documentation provided, the UK CAA will send an email confirming this.
