**General Permission** 

18th Federation Aeronautique Internationale (FAI) World Microlight Championship 2024 - Validation of Third Country Pilot's Licences, Ratings and Medical Certificates

### Background

- 1) This permission is being issued, to support the FAI World Microlight Championships 2024, by permitting, subject to specified conditions, the acceptance of Third Country Pilot's licences, ratings and medical certificates that do not satisfy the relevant minimum standards established under the Chicago Convention for those individuals taking part in this event.
- 2) The event takes place between 27 July 2024 and 3 August 2024, this permission is valid from 20 July 2024 until 11 August 2024, to provide time for pilots to familiarise themselves with flying within the United Kingdom; but also taking into consideration possible delays which may be outside the control of the event organisers.

#### Permission

3) The CAA, pursuant to Article 151(3) of the Air Navigation Order 2016 (as amended), hereby permits, subject to the conditions in paragraph 4), any individual registered with the British Microlight Aircraft Association as a competitor in the 18th FAI World Microlight Championship 2024 to fly in United Kingdom airspace for the purposes of travelling to or from that competition, preparing for that competition and taking part in that competition, only where that individual is operating an aircraft for which they hold an appropriate licence, rating and medical certificate, and where that aircraft is registered in the same State as that of the State of licence issue or is a UK (G) registered aircraft.

## Conditions

- 4) a. The British Microlight Aircraft Association must compile a register of all individuals who are registered to compete in the FAI World Microlight Championships 2024, which must contain the following details relating to each registered individual:
  - i. Name and address;
  - ii. Details of pilot licence held;
  - iii. Details of medical qualification held;
  - iv. Details of aircraft to be flown.
  - b. The above-stated pilot licence, ratings and medical qualification must be valid in all respects based on the requirements of the State of licence issue.
  - c. The British Microlight Aircraft Association must make the above-stated information available to the CAA upon request for review at any time during the period of this permission, and until the 31 December 2024.
  - d. Individual competitors must comply with the mitigation measures set out in the 18<sup>th</sup> FAI World Microlight Championship 2024 risk assessment document, in the section *'Overseas pilots with limited experience and non-UK licence holders flying in UK airspace.'*

#### Date in Force

5) This permission has effect from 20 July 2024 until 11 August 2024, both dates inclusive, unless previously revoked.
