Decision revoking Alternative Means of Compliance, for UK Regulation (EU) No 1178/2011 and UK Regulation (EU) 2015/340, previously proposed and/or accepted by the CAA

Background

- 1. CAA UK-EU Transition Decision No. 1, dated 22 December 2020, adopted Alternative Means of Compliance ("AltMoC") proposed and/or accepted by the CAA prior to Exit Day as a means by which the requirements in assimilated UK Regulation (EU) No. 1178/2011 and UK Regulation (EU) 2015/340 could be met.
- 2. The CAA publishes accepted AltMoC in CAP 1721.
- 3. The CAA has decided to revoke several AltMoC for UK Regulation (EU) No 1178/2011 and UK Regulation (EU) 2015/340, previously accepted by the CAA and identified below, as they have been subsequently adopted as UK AMC.
